Purpose: Election of Seventh District Central Committee officers

Call and authority

NOTICE IS HEREBY GIVEN that the Seventh Congressional District Committee will meet at the date, time, and location stated above for the stated purposes.

- Mitch Gore, as District Vice Chair, is assuming the duties of District Chair during the chair vacancy and calls the election to fill the District Chair vacancy. He will preside over that election and cast any tie-breaking vote for District Chair. (*IDP Rules 14(e)(1) and 14(e)(2)*)
- Karen Tallian, as State Chair, calls the elections to fill the District Secretary and District Treasurer vacancies. She will preside over those elections and cast any tie-breaking vote. (*IDP Rule 14(e)(3)(A)*)

Candidate filing requirements

A candidate must be a Party member, a qualified voter, and a resident of the Seventh Congressional District. (*IDP Rule 14(c)(1)(A)-(C)*).

A 72-hour candidate filing requirement is imposed for the offices of District Chair, District Secretary, and District Treasurer. (*IDP Rules 14(d)(3) and 14(e)(2)*)

A person seeking election to any listed office must submit a notice of candidacy that is received by 4:00 p.m. EDT on Sunday, July 26, 2026. The notice must identify the candidate's full name, residential address, office sought, telephone number, and email address. **Notices of candidacy must be sent to:**

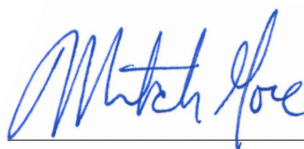
A note from the District Chair: State Party rules mandate that a mailing address be included as an option for notices of candidacy. Use of email is strongly preferred and highly recommended. Use of U.S. Mail for delivery of notices of candidacy is likely to result in late notice and failure to be included in the list of candidates, which cannot be remedied or contested during the meeting.

Qualifications, attendance, and voting

- A candidate must be a Party member, a qualified voter, and a resident of the Seventh Congressional District. (*IDP Rule 14(c)(1)(A)-(C)*)
- The district committee consists of the chair and vice chair of Marion County. Only eligible committee members, including valid proxy holders, may vote. (*IDP Rule 14(b); Rule 21*)
- Any proxy must be submitted in writing, which includes email, to the District Chair or District Secretary Pro Tem (both Mitch). A proxy carrier at a district meeting must be a Party member and a resident of the Marion County. (*IDP Rule 21(a)-(c)*)
